#### ABOUT KADIR HAS UNIVERSITY

The foundation studies of our University have been started in 1992 by Kadir Has Foundation (HASVAK) under the leadership of dear departed Kadir Has. However, its official establishment was finalized with the Law No: 4263 dated 28.05.1997. Selimpaşa Campus construction was initiated in 1998 and the restoration of the historical Tekel Cibali Cigarette Factory on the Golden Horn shore, which constitutes the main structure of the Central Campus, was started in 1999. The University, which included the Bahçelievler Campus in its existing campus area as of the 2000-2001 period, has been continuing its academic activities in the Cibali, Selimpaşa and Bahçelievler campuses as of the 2001-2002 academic year. At the end of 2007, the modern D Block was constructed with the aim to enlarge the Cibali Campus area. The Sports Hall and associated facilities were built in 2008 in collaboration with Fatih Municipality. Cibali Campus was renamed as Kadir Has Campus on March 28, 2007. The founding rector of the university, Prof. Dr. Ergür Tütüncüoğlu handed over his duty in 2002 to Prof. Dr. Yücel Yılmaz, who then delegated this in 2010 to our third rector Prof. Dr. Mustafa Aydın. In March 2018, our fourth rector Prof. Dr. Sondan Durukanoğlu Feyiz has taken over this duty from Prof. Dr. Mustafa Aydın.

In line with the goal of becoming a worldwide renowned research university, Kadir Has University is a non-profit center for academic education, research and science that offers academic activities under the basic headings of education, research and community service and puts emphasis on a new education model that aims to raise individuals with basic humanitarian and universal values such as social responsibility, human rights and environmental awareness. Sustainable development goals constitute the basis of our university's vision of serving the community.

Our university has been among the signatories of the United Nations Global Compact since 2009. The University was ranked 5th in Turkey and the 93rd in the world in the field of gender equality in the THE University Impact Ranking 2019 that was structured in line with the United Nations Sustainability Development Goals and is initially published in 2019 by *Times Higher Education*. Furthermore; our university has been evaluated in the top 101-200 category in the rankings of <u>Qualified Education</u>, <u>Reducing Inequalities</u>, <u>Decent Work and Economic Growth</u>, <u>Peace</u>, <u>Justice and Strong Institutions</u> and <u>Sustainable Cities and Living Spaces</u>.

Another significant achievement of our university that expresses its mission of being a foundation university is the scholarship rate that corresponds to a full scholarship. Considering the students who have been placed in our academic education programs as of September 2018, we can say that all of our students have been placed with some kind of scholarship thus the scholarship rate, which corresponds to a full scholarship, has reached 59%. Eğitimde Umut (Hope for Education) Scholarship, which is planned in line with our university-industry cooperation as a part of our new education model, aims to reach a scope above the current level of our university's scholarship policy.

## **SDG 1 - NO POVERTY**

## **Directorate of Core Program Activities**

Three of our projects developed in the Spring Term of 2019 - 2020 Academic Year within the scope of the Social Responsibility Project course aimed to contribute to the academic education of the financially disadvantaged children living around Cibali.

## **Projects**

• "Balat Kid's House" project: Balat Kid's House is a public place that poor children living in the neighborhood of Balat, which is located one and a half kilometers away from Kadir Has University, visit after school and participate in various activities organized by university students. Our students visited this place within the scope of their course curriculum, met the children who regularly visit the venue and have developed activities suitable for children. The activities have been developed to appeal to children of different age groups and allow children to discover their interests.

## Workshops

• **Future's Workshop:** The Future's Workshop project is a creative literacy project that aims to gain elementary school students the habit of reading books and is designed to improve their understanding, analysis, logic and reasoning skills. Negotiations were held with the administrators of Riyaziyeci Salih Zeki Primary School in order to incorporate 3. class students to the workshop within the scope of the project. Books appropriate for the age group of these students were selected and discussion questions and activities on the content of these books were prepared.

• **Cinema Workshop:** Cibali Secondary School 5th grade students were projected as the target audience of the project. It is planned to watch movies with the students and then do workshops. Within the scope of the activities designed as part of the workshop, the children were asked to draw their favorite scene in the film, summarize a point they learned in the film in a few words, to paraphrase how they could apply them in their real life and they were asked to design a character or item they liked in the film with play dough.

The first interviews about the projects were held, however these could not be implemented due to the pandemic outbreak and remained at the planning stage. These projects are planned to be brought to the agenda within the scope of the course curriculum as of the 2020 - 2021 Academic Year Spring Term.

## **Directorate of Core Program Activities**

One of the objectives of the KHAS Core Program is to ensure students who have received academic education with different perspectives to gain the questioning, inclusive, and investigative perspectives expected by university students in the first semester of their first year. In this context, we care about creating an academic environment where the student is expected to collaborate with the lecturer in preparing the course curriculum, access the information they need and enrich the course content with his/her observations, comments and questions rather than being a passive audience. Our English instructors in the program work in collaboration with professors from different majors and guide students in developing academic competencies in writing, presenting, reading, discussing, and researching through critical engagement with the content of the courses. The Core Program has been initiated with 18 students as of the 2019-2020 Fall Semester. The feedback received from the students is rather positive and the academic success rates of the students are really high.

## Conference: International Day for the Elimination of Violence Against Women November 25, 2019

To commemorate November 25th, as the Gender and Women's Studies Research Center, we organized a panel with the main theme of "Media" and the slogan was #WeSeeViolence. In addition to the panel, we worked with a number of student clubs (KHAS Law Club, KHAS Psychology Club, KHAS+ -- Student Club of Sexual Identity and Sexual Orientation Studies Club, KHAS Cinema Club, KHAS Theater Company and KHAS Music Club) to put on a week's worth of activities to raise awareness about gender based violence.

## • Seminar on the Importance of Gender During Covid-19 Days

As part of Coronavirus quarantine activities, the Center's director Prof. Dr. Mary Lou O'Neil delivered a talk on the importance of a gender perspective when discussing COVID-19. The talk was part of the Center for LifeLong Learning activities.

## Survey: The Perception of Gender and Women in Turkey 2020

This annual survey is one of the hallmarks of the Center. Each year, the Center conducts this survey to monitor the general trends among people in Turkey regarding women and gender issues. The survey focuses on questions related to women, family and society; women and work life; equal opportunities in business; social roles and working relationships; approach on women and LGBTI rights; abortion; women and politics. The study was conducted with 1216 people 18 years old and older representing the urban population of Turkey. The 2020 survey results show that in general, there is progression in perceptions of gender equality between women and men. However, women report a more egalitarian orientation than men.

## • Situation of LGBTI Employees in the Public and Private Sector in Turkey – 2019

This research has been conducted by the Kaos GL Association for the private sector since 2015 and for the public sector since 2017. The focus of the research is the hiring processes, general working conditions and personal experiences of discrimination of the LGBTI+ employees of different sectors. Since 2018, Kadir Has University Gender and Women's Studies Research Center has also been part of the team. In 2019, there were 228 public sector and 772 private sector participants. In line with the findings of previous years, very few employees completely disclose their gender identity, sexual orientation or intersex situation in their workplaces.

### Talking About Safer Sex 11.12.2019

The Center and KHAS+ (Student Club of Sexual Identity and Sexual Orientation Studies Club) organized a panel on December 11, 2019 on the topic of safer sex. Obstetrician and Gynecologist Dr.Irmak Saraç and Sexual Health and Reproductive Health Educator Berat Can Erdoğan talked about safer sex and answered the questions asked by audience.

## • Presentation on Gender of Life in Turkey for Lead Network

Prof. Dr. Mary Lou O'Neil was a guest of the LEAD Network (Leading Executive Advancing Diversity) monthly meeting. The network supports women leaders working in the retail and consumer products sectors and aims to increase the number of senior female managers and contribute to their development. The February meeting was hosted by Coca-Cola İçecek. In the presentation, O'Neil discussed the issue of gendered language, the division of labor in the home and issues that face working women. O'Neil emphasized that we should avoid language that includes sexism and discrimination for an inclusive and egalitarian work environment.

## Presentation on Gender Equality and Struggle Practices for Yemeksepeti 09.03.2020

As part of celebrations surrounding International Women's Day (March 8) Deniz Altuntaş from the Center made a presentation about Gender Equality and Practices for the employees of Yemeksepeti on Monday, March 9. During the seminar Deniz and the participants discussed what can be done both as an NGO and as an institution in the struggle for gender equality. Deniz also discussed with the participants on what can be done both in the company and in their daily lives to advance gender equality.

#### Guide for Safer Sex

In order to develop the information and advocacy capacities of young people about sexual health and safer sexual practices, we as Kadir Has University Gender Identity and Sexual Orientation Studies Club (KHAS +) and Kadir Has University Gender and Women's Studies Research Center, prepared a Guide for Safer Sex. This guide was prepared with the support of Turkish Family Health and Planning Foundation (TAPAV). ## • Access to Emergency Contraception in Istanbul

Access to EC in Turkey - specifically in Istanbul - is expensive and not always guaranteed. EC is widely available at pharmacies although price is an issue and accessibility is marginal at best at government supported Family Health Centers (Aile Sağlığı Merkezleri). Accessibility to EC is crucial for women's reproductive health and rights. The project aims to determine whether access to EC varies depending on the district within Istanbul, and between pharmacies and Family Health Centers.

## Nursery / Daycare services provided by universities for academic and administrative staff

This research includes 127 public universities and 73 private universities. It investigates whether the universities provide academic and administrative staff with access to nursery or day care support for their children. Employer supported access to childcare facilities is vital for work life balance for all employees, both women and men, as well as supporting women's return to work after childbirth.

## Units on Gender Equality, Sexual Violence, Mobbing and Student Clubs at Universities

This research investigated whether universities in Turkey (127 public universities and 73 private universities) have regulations, directives, units and/or student clubs regarding discrimination, gender equality and gender-based violence.

## Research on individual, familial and social factors that protect subjective well-being during the pandemic of COVID-19 (TÜBİTAK)

Research on individual, familial and social factors that protect subjective well-being during the pandemic of COVID-19, has been funded by TÜBİTAK. The project manager of this research is Member of the Executive Board of our Center, Assoc. Dr. Aslı Çarkoğlu. Also, Manager of the Center Prof. Dr. Mary Lou O'Neil is in the research project team. The primary aim of the study is to examine the impact on subjective well-being of adults in Turkey during the pandemic of COVID-19 in terms of health psychology, family and women's studies and to develop solutions at various levels (individual, family, policymaking).

## • GenderEX: Gender for Excellence in Research (H2020-Widespread Project)

The Widespread (Twinning) titled "GenderEX: Gender for Excellence in Research" has been funded by the European Commission for three years from 2021-2023. The project will be coordinated by the KHAS Gender and Women's Studies Research Center. The project team consists of: Prof. Mary Lou O'Neil (coordinator) and Assoc. Professor Salih Bıçakçı (researcher) and Asst. Prof. Şebnem Eşsiz (researcher). KHAS is partnering with Technical University of Dublin, University of Genoa, and Lund University for the project.

## **Directorate of Core Program Activities**

One of the basic 5 modules of the "KHAS 105 Universal Values and Ethics" course, included within the compulsory courses of Fall semester in the KHAS Core Program, focuses on the topics of Gender and the Gender Equality. In this module, the subject is discussed thoroughly in both historical and current aspects by reviewing cases from Turkey and the world and thus it is intended to raise the awareness of the students significantly. Students taking this course in Fall 2019 were required to do research within the scope of this module and they have prepared discussion forums focusing on different issues related to gender inequality topic in Turkey.

## **Faculty of Economics, Administrative and Social Sciences Activities**

## Courses

• **PS 353 Gender and Politics** is lectured. This course aims to show students how the issue of gender shapes politics. The course provides an analysis on the key concepts related to politics and gender. For example, the effect of gender on citizenship or voting behavior is examined. Issues such as the importance of the gender for our political representatives and balance of political institutions in terms of gender are discussed. In addition, topics such as women's rights and human rights, the international development of gender and the role of gender in armed work are also covered.

55 students were enrolled in this course in the Fall semester of the 2019-2020 academic year and 83 students in the Fall semester of the 2020-2021 academic year.

• **PS 356 Women and Gender Studies** course is lectured. The aim of this course is to introduce students to the concept of "gender" and to enable them to analyze gender. This course aims to enable students to systematically study women and gender. Within the scope of the course, the concept of gender and its effect on the daily life of men and women are discussed. In addition, broader topics such as media, law, sex and politics are also examined from this perspective.

22 students were enrolled in this course in the spring semester of the 2019-2020 academic year.

• PS 343 Social Change and Development course is lectured. This course aims to enable students of political science and public administration to make connections between the economic and political economic dimensions of development. It is aimed for students to see the reflection of the international view of politics and development at the local level. In this way, students will be able to establish a link between global and local politics. The Social Change and Development course, which will convey the basic

concepts and debates on social change, examines the relationship between modernization and development. Various dimensions of development are covered through case studies on Latin America, the Middle East and South and East Asia.

20 students were enrolled in this course in the Fall semester of the 2019-2020 academic year and 16 students in the Fall semester of the 2020-2021 academic year.

• İstanbul 95: Reviewing and Mapping Services for Children and Family in İstanbul District Municipalities (2016-2020)

TESEV, with the support of the Bernard van Leer Foundation and in collaboration with the Kadir Has University Istanbul Studies Center aimed to take a comprehensive inventory of the social services offered by district municipalities for children and families and to develop policy recommendations to improve the distribution and content of these services within the framework of the socio-economic differentiation of the districts of Istanbul. The project consists of three stages. First of all, districts of Istanbul were mapped on the basis of education, age group and income by using neighborhood bases in the geographical information system environment. The resulting up-to-date and detailed maps clearly reveal the distribution of the child population in districts as well as differentiation with respect to education and income between districts and neighborhoods. With the fieldwork carried out in the second phase, services provided by the municipalities such as education and health care for children and families, parks and green spaces, social assistance were examined through interviews with 39 district municipalities. At this stage, many variables such as the quality of the services provided, their means of administration,

employees providing these services and the demographic characteristics of those who benefit from the services have been examined. All data collected and analyzed were mapped interactively and disclosed on the website <a href="mailto:belediye.istanbul95.org">belediye.istanbul95.org</a> available for the use of all relevant stakeholders, especially decision-makers.

## Kent95: Data-Based Policy Tool (2019-2020)

Kent95: In the Data-Based Policy Tool Project, the services offered by the Istanbul Metropolitan Municipality in addition to the services provided by the district municipalities in Istanbul were integrated with the data related to both public and private preschool education and health institutions over certain variables and transferred to the interactive platform produced in the previous project. Besides widening the scope of the data in Istanbul, services provided by Izmir and Gaziantep Metropolitan Municipalities were also included in the project.

Data regarding the services provided by Izmir Metropolitan Municipality has completely been transferred to the platform. Data on the services provided in 11 districts in Izmir city center are still being collected. Data on the services provided by Gaziantep Metropolitan Municipality and district municipalities are still being collected.

This interactive platform is designed as a tool that facilitates local governments to monitor existing services for children and develop strategies for the projected services.
